H.O.B.O. volunteers more than met the call for help at the Fish Habitat Enhancement event on a cold and rainy February 1. It was a great turnout of approximately 33 persons. A total of 201 trees were installed at various locations around the lake. The GPS coordinates will be added to the <u>www.alabamapower.com/fishdata</u> website later this spring once all the habitat work around the state is completed. My thanks go to those who participated in the work to improve the fishing habitats at Lake

The news on the Marine 9 Fire and Rescue boat is very positive in 2012. Steve Miles, our liaison with East Chilton Volunteer Fire Department, reports that George Fanning is the new Fire Chief at East Chilton. Chief Fanning is very supportive of the Marine 9 operations on the lake. The boat is expected to have a new radio installed that is compatible with the Chilton County 911 Communications System. A contract for new upholstery is out for bid to complete a series of major repairs on Marine 9 during the past year. We should have a fully operational fire and rescue boat on the water before Memorial Day.

Do mark your calendar to attend the Annual Lake Mitchell H.O.B.O. picnic on June 2. The Trobaugh Pavilion has been reserved for this fun activity. We are optimistic that the weather will be good, and we know from past experience that the food is really good. Best of all, it is one of the best H.O.B.O. events at which you can meet your Lake Mitchell neighbors from every area of the lake.

Area 5 – Sonny and Peggy Bullard



Fishing, boating, and just plain summer fun is just around the corner.


Hopefully, the break-ins have been stopped due the arrest of two from Chilton County.

Membership dues explained by Jim McCormick, Treasurer

The Lake Mitchell Home Owners and Boat Owners Association (H.O.B.O.) was formed in 1996 through the vision of Dan and Judy Murchison. At that time membership dues were established at \$25. We have maintained that level for 16 years without a single increase. And during this time, your organization has never had a debt, a loan or a past due bill!

As your treasurer, I would like to tell you how your Board puts our collective H.O.B.O. dues to work.

We will start with the Lake Mitchell H.O.B.O.'s mission statement, which is to "Preserve. Protect. Improve." Our lake would not be what it is today if we did not diligently work to preserve, protect and improve our water quality.

We have an Environmental Committee that works with Alabama Power Company, Alabama Water Watch

and other organizations to monitor what our water shed is filtering into our Lake. Your dues H.O.B.O. purchase the water testing kits and supplies that our monitor water volunteers use to regularly test the water at various points along our lake.

We spend about \$800 per year on our semi-annual lake cleanup events where many volunteers comb the lake cleaning hundreds of pounds of litter and trash from our shores. After depositing the bags of debris, workers celebrate at Higgins Ferry Park with a picnic provided by your \$25.

Your H.O.B.O. association is also civic minded. Each year we award a \$2500 scholarship to a local Coosa or Chilton County high school senior. The H.O.B.O. Scholarship Committee accepts and reviews applications, works with school counselors, and interviews each applicant to select the scholarship recipient. H.O.B.O. is also a dues-paying member of the Chamber of Commerce, and we make a donation to the local church in Clanton that allows us to use its facilities for H.O.B.O. board meetings.

We spend about \$1000 annually to mail meeting notices, cleanup announcements and picnic invitations.

Every two years we spend almost \$3000 to collect the data, print, and mail our lake resident telephone

directories. These books are provided at no additional charge to H.O.B.O. members.

With the help of Alabama Power Company, H.O.B.O. provides this quarterly newsletter to all lake residents.

Area Representatives have \$400 in the budget to use to communicate with their area homeowners and to host local parties or events for their area members.

We spend about \$500 to feed all members and families who attend the summer picnic held at Higgins Ferry boat launch.

The largest community events we support surround the Fourth of July. All can enjoy and any can participate in the two boat parades – the party boat parade in the morning and the ski boat parade in the afternoon. After the sun goes down, we all gather in Cargile Creek to enjoy the Lake Mitchell fireworks show. Your dues provide a portion of the cost of the fireworks. Many members also make a specific fireworks donation to help offset the cost of the show.

We have a unique form of protection provided by our fireboat, known as Marine 9. the designation given by the East Chilton County Fire and Rescue unit that mans the boat. I know of no other lake our size that

can claim a boat this large, this fast, with as much onboard life-saving equipment. The boat was purchased in 1998 with proceeds from our dues, donations, yard sales, raffles and a skeet shoot. Since this time we have invested thousands of dollars in a defibrillator, pumper, a boathouse and fireboat maintenance.

And all of this for \$25!!!!!.

I hope you will all agree that your investment in the Lake Mitchell H.O.B.O. is a good value. Please make sure that you have paid your dues for 2012 and encourage your neighbors to join as well.

For every check we write, for every cause we support, we need to make sure our money is used wisely. You can have input into those decisions. Get involved in H.O.B.O. today. Contact any board member or your Area Representative to learn ways you can volunteer.

Fireworks set for July 7

Because Independence Day falls on a Wednesday this year, the annual fireworks display in Cargile Creek will be held on the following Saturday evening, July 7, at 9 p.m.

This annual event that we all anticipate eagerly doesn't just magically happen. Jim McCormick and his team begin the planning and preparation in March.

By April, the music that will accompany the display has been selected and mixed in the studio. Hopefully this year we will have an enhanced broadcast on 96.9 FM, but for most, you can hear the synchronized music over the sound system.

ATF has approved our license and we have applied for the State Permit.

Selection of the fireworks begins in April. This year new product has become available that will add even more variety to the 400+ shells we display.

A day or two before the show, the pace of activity really picks up as last minute preparations move into high gear. Safety is always a top concern as the sound system is tested, the mortars are positioned, and the firing cables are connected. We run a firing test to be sure all of the electronics are properly connected about 30 minutes before the 9 o'clock hour. Then we take a deep breath, the adrenalin sets in, the music starts, and shell by shell is ignited by simply touching individual "buttons" one by one.

Months of preparation and coordination culminate in a spectacular display over Lake Mitchell for 17 minutes each July.





You are Our Environment

Here at Lake Mitchell, we all enjoy the wonders of our natural environment. We see daily evidence of things that lead us to believe that we have a healthy and safe lake environment. We see water that is relatively clean and free of odor, making it enjoyable for swimming and other water sports. We watch as wildlife flourishes with darting dragonflies, skittering water striders, diving coots, kingfishers watching for the perfect fishing moment, great blue herons standing motionless in the shallow depths, and the return of the great Bald Eagle, hurling itself into the water and recovering with a fish in its talons. We see turtles sunbathing, sunfish swimming in the shallows, baitfish darting across the surface and even the occasional beaver. Around our lake we see wildlife plenty and plant life bursting at the seams. All this indicates to us that our lake must be healthy and safe.

However, it is the things that most of us hardly ever pay attention to that really determines the true health of our lake. It is the health of the larvae found on the grasses and reeds in the lake that produce the dragonflies. It is the microorganisms and algae found in the water columns that support the fisheries of baitfish that allow us the bream, crappie, bass and catfish we enjoy catching. And it is the ability for the lake to stay in balance with the nutrients, sediments, and bacteria that protect this living system.

Lakes, like the plants and animals that live on and around them, are ecosystems - living laboratories with chemistry, biology, and mineralogy all represented. These things we normally expect others to worry about and to monitor. Don't we have Federal, state and local agencies that have missions to do these things?

Even if that were the case, in these times of reduced budgets, these agencies are fighting for their lives to deal with only the most severe issues. Our Alabama Department of Environmental Management has had a 60% total cut from its General Fund budget in the past three fiscal years. This now threatens our EPA Federal funds that require State matching dollars. Fortunately,

our Lake Mitchell H.O.B.O. has a tremendous and successful history of having our members work hard to implement programs to protect and improve our lake. For example, this past year H.O.B.O. provided a donation to Alabama Water Watch, which was at risk of not being able to continue their program

without support. We have had a long history of volunteer water monitors as a part of Water Watch on our lake, and we are now up to 11 trained monitors. Jim Woodrow sits on the Alabama Water Watch Board and our Environmental Committee.

The Renew Our Rivers Cleanup Program sponsored by Alabama Power has been and continues to be well attended by our members. Dan Murchison participates on the Coosa River Basin Clean Water Partnership as our Lake Mitchell liaison and serves on our Environmental Committee. And there are many, many more that work for our Lake environment.

You see in these times of the "great recession" we all know that **we** have to make the difference in our environment, not just government agencies. We have a wonderful gift in our lake and the lands around it. And we have had and continue to have a H.O.B.O



Board Environmental Committee that wants to see it get even better.

The State of Alabama recently passed into regulation the designation of *Treasured Alabama Lake*. Lake Martin is the first and only lake so far to receive this honor because of the high standards required. We want to set a vision for our Lake Mitchell to achieve this designation. It will not be easy - since we receive water from other lakes upstream and we don't control their actions - but we can do it on our lake with your help.

And your help is what I need. We need members for our Environmental Committee from around the lake to set a real strategy for our Lake environment, to communicate this strategy, and to help implement it.
