Apply for Your Shoreline Permit Before Beginning Construction or Maintenance

Remember, if you have plans to do any maintenance or construction along the shoreline you need to obtain a permit from Alabama Power. Don't wait until you are ready to start your project to apply for your permit because sometimes it may take several weeks before a permit is issued, depending on the number of requests to be processed by Alabama Power. Once a permit is obtained, projects must be completed within one year of the date of the approved shoreline permit.

The program's general policies are:

- 1. Alabama Power encourages shoreline structure owners to maintain the upkeep of existing boathouses, docks and seawalls. Prior to beginning any maintenance, contact Alabama Power to obtain a nofee permit for repairs.
- 2. Alabama Power also encourages shoreline structure owners to remove noncompliant structures and replace them with compliant structures, and upon doing so will be issued a no-fee permit (e.g. replace an enclosed boathouse with an open boathouse).
- 3. A permit to build any new shoreline structure will incur a one-time \$250 fee (e.g. new boathouse, new dock or new seawall). More than one activity may be authorized with a single permit.

The Alabama Power Shoreline Management Team strives to protect and enhance the scenic, recreational and environmental values of the reservoirs it manages. As part of its mission, Alabama Power Shoreline Management is dedicated to ensuring all of the structures along Lake Mitchell's shoreline comply with the shoreline management program developed by Alabama Power with the input of its local, state and federal regulatory partners.

Please call Alabama Power Shoreline Management Team Member Candy Hayes at 205-280-4476 to discuss your project/work and to obtain a permit prior to beginning any maintenance or construction.



Environmental Update


As spring has come, I want to provide an update of the recent activities of the Lake Mitchell H.O.B.O. Environmental Committee. The Alabama Water Agencies Working Group and the Water Policy and Management Joint Legislative Committee proposed legislation in Montgomery to require a State water policy report be recommended by the end of 2013 so it can be considered for any required legislation in next year's legislative session. We will continue to track progress on water policy for the State and ensure our interests are communicated.

Additionally, we have worked since the beginning of the year with the Coosa River Basin Clean Water Partnership Group and the Riverkeeper to have Walnut Creek considered for funding to improve the water quality that enters our Lake. Thanks to many of you who took the time and trouble to submit nominations for Walnut Creek to the Alabama Clean Water Partnership. You were successful in getting Walnut Creek put near the top of the priority list. Hopefully this may result in future assistance for the cleanup and restoration of this important tributary into Lake Mitchell.

We also met with the Mayor of Clanton regarding Walnut Creek with H.O.B.O. President Lee Poe, Marie and Hugh Greene, Dan Murchison, Scott Phillips, and the Coosa Riverkeeper - Frank Chitwood - in attendance. This meeting was to learn more about the past flooding and dredging done on Walnut Creek by the U.S. Army Corps of Engineers to correct the flooding in the city of Clanton, but which appears to have contributed to some of the erosion issues along Walnut Creek. We also discussed with the Mayor some of the water pollution issues we have observed on Walnut Creek entering the Lake to try and enlist his support in preventing them in the future. We continue to seek support in improving the water that enters the lake from Walnut Creek.

And finally, we continue to monitor the planned graphite mine and facility in Coosa County. Alabama Graphite has completed their exploratory drilling and are now awaiting the results from the samples they collected. They expect these results at any time and this will allow them to determine the mineral reserves and financial viability of the project. They have not submitted permits at this time but we will continue to communicate with the Company to ensure they are aware of our concerns and interests. The company could provide a number of jobs in our area, which would be a positive. However, we in H.O.B.O. also want to ensure that any mining next to our beautiful lake will be done in an environmentally responsible manner that will not have negative impact upon our water quality and beautiful surroundings.

We hope everyone is having a wonderful spring!

Hiking Trails to Open Soon in Forever Wild Lands

Forever Wild will soon have about 11 miles of hiking trails open in their approximate 9000 acres of land in Coosa County. This property touches Hatchet Creek to the East and the main channel on the West, also going over Weogufka Creek.

The State Lands division of the Alabama Department of Conservation, along with members of the Alabama Hiking Trail Society, have been working on the trail system which should be ready by the end of May. It will be open to foot traffic only, no motorized vehicles or bicycles allowed. The trail is described as moderate to strenuous.

The trail system starts at the parking lot next to Double Bridges on Hatchet Creek and will terminate at a trailhead located at the intersection of Wildlife Management Association (WMA) Roads 153 and 128. The actual tread and blazing of the trail is complete., and work is underway to post directional signage along the trail, establishing the Western Trailhead parking lot, and designating the campsite sites for the trail. An official press release will be sent out announcing the Grand Opening of the trail system once complete.

Currently there is only one boat access point located at Double Bridges on Hatchet Creek. It may be possible to establish a location along Noneless Creek that may be accessible by boat as well.

Each must write an essay on what they consider to be the most important environmental issue and what they can do to make a difference regarding that issue. Applicants must take part in one of the lake clean ups or water monitor training.

Through Lake Mitchell calendar sales and your donations, we have already given four \$2,500 scholarships to help area students.

Fish Habitats Replenished

In February and again in March representatives from Alabama Power, Lake Mitchell H.O.B.O., and Wildlife and Freshwater Fisheries, a division of the Alabama Department of Conservation, dropped hundreds of recycled Christmas trees into different areas of Lake Mitchell to provide new fish habitats.

Alabama Power environmental specialist Doug Powell said the purpose of dropping the recycled trees into the lake is to help provide cover for fish and enhance a nursery habitat for juvenile fish that will often burrow deep within the trees creating a home to hide inside.



The crews delivered the trees via boats, dropping them into water that was 12-15 feet deep. The March crew consisted of Rick Shrader, Bob Thornton, Jim Quinn, Bobby Hyde, Stan Holt, Keith Welch and Steve Miles from Lake Mitchell; Doug Powell, Mike Clelland, Daniel Hatchett, Kevin Bass and Danny Wright from Alabama Power; and Graves Lovell from ADCNR

The trees are bundled into groups of four and weighted down with three 12-inch concrete blocks with a piece of foam attached to the top of one of the trees to let fishermen know where the habitats are located.

Alabama Power started the recycling program with various lakes in Alabama in 1992 and at Lake Mitchell in 1996. Since the program begin more than 56,000 Christmas trees have been recycled into Alabama lakes as fish habitats.

"When we place each bundle of trees in the lake, we record the coordinates with GPS of the different sites to keep track of where we have placed the trees," Powell said.

The Inspiring Story of a Pennamotley Hero – by James Hand

Twenty-five years ago, my friend Billy was talking to my younger son, Andrew, who was around five. Billy asked, "Andrew, who is your hero?" Andrew gave it serious thought and then announced his hero was Davy Crockett! Billy just nodded his head in sound agreement. The next day Billy came by our house with a gift for Andrew. When Billy had been a young boy growing up in Montgomery, he had met Davy Crockett (Fess Parker) and got an autographed baseball card of him. Billy had hunted down the old card and brought it to Andrew. Andrew still has the card today.

I was very proud of Andrew's answer. In a world where young people were saturated with cartoon and sports figures, he picked a hero who always looked out for others and always did what was right for his family, friends and community.

If someone had asked me in the past, "Who is your hero?" I'm not sure I could have given them an answer. But today I know a real hero from right here on Lake Mitchell, and I want to share this story with you.

Toby and Jamie Vinson have a house next to us in Pennamotley. One Saturday morning I was out walking and noticed Toby fishing. I always hate to ask Toby how he's doing fishing because he always does so much better than I do; in fact most times when we meet fishing he'll have pity on me and either offer to take me in his boat or "suggest" that I might have better luck using such and such lure. But that's Toby, just a good guy. We went through the usual - how is everyone.

Then he told me about his wife, Jamie.

Jamie is in the insurance business and does a lot of her work from home. One of her business acquaintances is a lady named Michelle who lives in Dallas, Texas. Jamie has talked with Michelle for several years but never met her face to face. Five years ago Jamie discovered that Michelle needed a kidney transplant. Out of this urgent need, Jamie nurtured a relationship with Michelle based on faith, hope, God and prayer.

Twenty-three people were evaluated as possible kidney donors. As each prospective donor was tested Jamie supported Michelle with prayer in the hope God would provide an acceptable match. No such donor was found. Upon hearing this, Jamie announced that she herself wanted to be tested as a kidney donor for Michelle. She proved to be a perfect match!

In my conversation with Toby, I learned that Jamie had flown to Dallas the prior week where she donated a kidney to Michelle. Toby said Jamie was already home and doing well and feeling great.

As I continued my walk, I was speechless from the information Toby had shared with me. I had a hard time grasping someone doing this for another person that she had never even met face to face.

That's when I ran into Jamie walking by herself down the dirt road. I asked how she was feeling and she said, "Great!" I told her I had talked to Toby and knew about what had happened in Dallas, Iamie looked down at the ground and did her best to down-play the whole thing. I told her I didn't know if I could ever be that unselfish. Jamie lifted her head up, looked me dead in the eyes and said, "Jim, it's a God thing!"

I knew when I saw her eyes it was, but I also knew I was looking into the eves of a true hero!

New H.O.B.O. Historian Is Gathering Your Stories

My name is Chip Gates and I am the new Lake Mitchell Historian. My wife, Jeanette, and I live in southern Jefferson County, but have a humble little lake cabin located at 54 County Road 555. In the front yard is the yet-to-become-famous bottle tree, presently known to the postal carrier, garbage folk, and the few who travel to the dead end of our little road. We are land-locked, somewhat straddling the line between Areas 1 and 2, but we are blessed to have relatives (both named DiGiorgio) behind us on a slough of Blue Creek, and in front on the lake proper. My wife's folks bought the cabin in the mid-50s, and then Jeanette purchased it in 2007 and our job of renovation commenced.

There was an old map of the lake on the living room wall and I soon noticed the notation of "underwater RR tr" near where our place is. Having a lifelong interest in trains, my curiosity was piqued. From talking to others in the area. I found out about the

former sawmill and the now submerged town of Rushton. I believe that part of the town was located on what is now a small island on the west side of the lake near the entrance to Blue Creek. Last summer I was paddling a kayak through a narrow and shallow pass between the island and the shoreline when I saw what appeared to be a stone foundation beneath me. My intention is to comb the island with a metal detector to see if I can find any artifacts to substantiate my belief.

George Jackins has already been a great help in furthering my quest for knowledge about the town. He graciously provided old maps of the river and tributaries (pre-Mitchell Dam) of which I had copies made, plus he obtained a copy of the book "Putting

Loafing Streams to Work".

As my interest in the history of learning some

Rushton began to grow, I started other little tidbits from of our other neighbors further on down Co. Rd. 555. John Haley told me one of the houses on his property was a speakeasy during

Prohibition, and he lays claim to

having the oldest boathouse on the lake. Another neighbor, Chan Aldridge, told of spending a night in one of the original logger's cabins near present-day Blue Creek Marina. Chan also talked about gold having been found way up in the hills beyond Blue Creek. I did find one old map on-line giving the name Rippatoe Mines in this area in the 1920s.

As I heard these stories I realized that it would be good to capture this information so as to preserve it. As the historian for the Lake Mitchell H.O.B.O., I would like to serve as a conduit and repository by which other people can submit stories about their part of the lake. These stories can be about people, places, and/or events that helped shape the Lake as we know it today.
