## FROM THE PRESIDENT

HOBO is active in causing many good things to happen on Lake Mitchell. The Fire/Rescue Boat Committee has the boathouse completed. The fish weigh-in and aerator structure for bass tournaments will soon be constructed. The membership committee is working on a lake phone directory for the entire lake which will be available for all members. Johnye Woodrow and the Picnic Committee did a fabulous job with our annual picnic. Our water monitors will soon be trained in soil erosion and wetland protection. Our committee is obtaining security neighborhood watch signs and is forming better communication with our sheriffs. Our membership is at an all time high. The budget is stable.

So what's the problem? Construction on the lake is at an all time high and

erosion/silt from construction sites and dirt roads threaten our aquatic life. Each creek entrance to Lake Mitchell is a miniature wetland where small fish, minnows and all sorts of aquatic creatures are born and reared. If we allow silt to smother these creatures we severely damage our fish population and other wildlife. So what can you do? Read and learn about wetlands and erosion. Seek advice before you start construction - it is free. Call the RC&D soil and water department in Clanton at 755-5101 - ext. 202 and talk with Ben Gary. If you have an area where silt is running into the lake, stop it with rock, hay and plants. Be a watch dog erosion problems to Alabama Power representative, Bo Warren, at 755-8959 or call Alabama Environmental

Watchdog line at 1-800-982-4364. Silt is not just dirt. It is dirt plus what attaches to dirt such as pesticides,

bacteria, PCB's etc. We <u>all</u> have a responsibility to keep Lake Mitchell clean and beautiful.



The fish tissue report just completed by Alabama Department Environmental Management in their testing of Lake Mitchell is summarized in these words: "Concentrations of PCB's continue to exceed the FDA guideline of 2.0 parts per million in samples of bass, crappie and catfish in Upper Lay Reservoir. Lower Lay, Mitchell and Jordan reservoirs also had elevated levels of PCB's in individual fish, but the contamination does not appear to be as severe." The Alabama Department of Public Health did not issue a fish consumption advisory for Lake Mitchell or Lake Jordan. You may get the entire advisory from the State

Health Department. Contact Brian Hughes, 334-206-5973. You may contact Dan Murchison at 755-0521 or 823-2308 and he will review the complete ADEM report and the Health Department advisory.

Quarterly Report Average Water Quality

A low dissolved oxygen level indicates a demand on the oxygen in the system. Pollutants such as inadequately treated sewage as well as decaying natural organic matter can cause low oxygen levels. The ph scale ranges from very acidic such as battery acid to very basic such as household lye. The midsection of the scale between 6.5 to 8.2 is optimal for most organisms. If a body of water has an abundance of buffering materials causing high total alkalinity, it is more stable and resistant to ph changes. When alkalinity is above 20mg/l there is a marked increase in nutrient utilization. Hardness refers primarily to the amount of calcium and magnesium, which enters the water mainly by leaching of rocks. Both minerals are essential to the development and growth of aquatic plants and animals.



### PHASE 1 COMPLETE



The Boathouse which will house the Lake Mitchell Fire/Rescue boat at Higgins Ferry Park has been completed. The Chilton County Commission joined with HOBO to construct the boathouse. Paul Minor was the low bidder and builder. The structure will house the Fire/Rescue boat as well as the Marine Police and the Park Ranger boats.

Lake Mitchell has had a death and a serious injury since this project began. The recent accidents and boating deaths on other Alabama lakes have added to the urgency to complete this project. (Lake Mitchell is the leader among all other Alabama lakes in realizing the need and initiating a plan for lake rescue.) The second phase is the boat. It will be a specially built and fitted 10' x 24' pontoon. The approximate cost will be \$30,000 for the boat. Financing Phase 2 is over 50% complete. With the help of the people and businesses of Chilton County and especially the lake community the boat should be on the lake by the end of September. The area fire departments have already started on-water rescue training.

Equipping the boat will be phase 3. The approximate cost will be \$25,000. The boat will carry the same equipment as a regular rescue truck and that of a regular fire truck. In addition there will be special equipment for water rescue. It will respond to calls over the entire lake. They still need

### ACCIDENT REPORTS

The summer is sailing right along and so far things have gone well on Lake Mitchell. The same cannot be said for some other areas of the state. In June there were three boating related deaths, two on Logan Martin and one on Lake Eufaula. These accidents happened under ordinary circumstances. The night accident on Logan Martin involved a pontoon and a bass boat, both properly equipped and lit. The bass boat decided to move and as he throttled up the bow of his boat blocked his view. This prevented him from seeing the pontoon. collision fatally injured two people. The Eufaula accident was between two personal watercraft (PWC). A mother and daughter were on separate PWC in single file. The daughter, caught off guard, collided with her mom killing the mom. The reason for relating these tragedies is that they could happen to anyone anywhere. It is a mistake to think only "drunks" are involved in accidents. It is also a mistake to think you are safe because the people in a boat or PWC near you are friends or family. How can accidents be avoided? Maintain a proper lookout and keep a good distance between vessels. Being mindful of these things helps keep Lake Mitchell one of the safest lakes in the state.
