Quarterly Report Average Water Quality

A low **dissolved oxygen** level indicates a demand on the oxygen in the system. Pollutants such as inadequately treated sewage as well as decaying natural organic matter can cause low oxygen levels. The **ph** scale ranges from very acidic such as battery acid to very basic such as household lye. The midsection of the scale between 6.5 to 8.2 is optimal for most organisms. If a body of water has an abundance of buffering materials causing high **total alkalinity**, it is more stable and resistant to ph changes. When alkalinity is above 20mg/l there is a marked increase in nutrient utilization. **Hardness** refers primarily to the amount of calcium and magnesium, which enters the water mainly by leaching of rocks. Both minerals are essential to the development and growth of aquatic plants and animals.

Safety, Shoreline Destruction, and Boat Noise Dan Murchison

These are currently major topics of discussion on all the major lakes. New home construction is at an all-time high which means significantly more boat traffic causing more wave action. Each new home generally means at least two new boats, 4-6 new children/grandchildren and their friends being pulled on wake boards, tubes, skis and personal water craft. Mom and Pop, Grandmothers and Granddads all want to see how their offspring perform; so running close to shore near our homes has been the preference. Most of us have been there and done the same thing. The problem now is bigger and more powerful boats, especially with the increase in wakeboarding (bigger waves), more homes, more boats, more people, etc. Waves do considerable damage to our piers, docks, and seawalls, and can be dangerous for those unfortunate enough to be sitting in a boat near a pier, children on rafts near piers, etc. when hit by a four foot wave. We have heard horrible stories about unfortunate incidents caused by just the boat waves. The Marine Police suggests that we stress to all that "a boat driver is responsible for his wave action". From a legal standpoint we are all responsible for "our wakes and any damage done". When a boat goes round and round in a highly populated area there is the potential for damage to piers and children playing in the water by their piers. The boat drivers/boat owners causing these waves can be held responsible.

Oh, did I mention the noise from the high fidelity speakers used by some boaters? This is costly for replacing the blown out hearing aids and ear drum damage to our senior (and not-so-senior) citizens trying to enjoy a day on the lake. Please show consideration for others by keeping your music down to a reasonable decibel level. Safety is also a big issue with the increased bass

tournament traffic and ever increasing speeds, bigger motors, and the race to get to that favorite spot first. Beware if you happen to be on the lake at take-off.

The lake associations are receiving these kinds of complaints weekly and are discussing the issues and how to handle them.
